Joint Committee on Administrative Rules and Regulations

Recommended 4 days

Below is a summary of the requested interim topics that were submitted as of June 19, 2019. The topics are organized by subject and include the individual or committee that is requesting a study of the topic.

REQUESTED INTERIM TOPICS BY SUBJECT

Administrative Rules and Regulations

Review All Proposed Rules and Regulations

(Requested by Chairperson, Joint Committee on Administrative Rules and Regulations – 6 days)

- 1) All proposed rules and regulations shall be reviewed by the Joint Committee on Rules and Regulations during the public comment period required by KSA 77-421 and amendments thereto.

Budget and Agency Issues

Review Expenditure and Revenue Information

(Topic 1, requested by the Chairperson, House Committee on Appropriations – 10 days)

- 1) Specific topics would include:
 - Transportation—Receive an update on T-WORKS projects and the use of the additional funds provided in FY 2019 and FY 2020;
 - Department for Children and Families—Review plans for the Family First Prevention Services Act programs, receive an update on the progress on filling the new approved social worker positions, and review the plan for

expenditures from the evidence-based initiative account (2017 SB 367) in coordination with the Department of Corrections and other agencies;

- Corrections—Review the use and impact of additional funding for prisons;
- Regents—Review the impact of additional state funding and the need for tuition increases;
