Agency Request

The **agency** requests a revised estimate of \$309.0 million, including \$74.9 million from the State General Fund for FY 2017. This is an all funds increase of \$10.8 million, or 3.6 percent, all from special revenue funds. The increase includes \$9.8 million in operating expenditures primarily for salaries and wages (\$7.6 million), commodities (\$2.5 million) and debt service (\$2.0 million) with an offsetting decrease in capital outlay (\$2.0 million). There is also an increase of \$1.0 million in capital improvements primarily for the new School of Business.

Governor's Recommendation

The **Governor** concurs with the agency's revised estimate.

Agency Request

The **agency** requests a revised estimate of \$309.0 million, including \$74.9 million from the State General Fund for FY 2017. This is an all funds increase of \$10.8 million, or 3.6 percent, all from special revenue funds. Senate Action

There was no budgetary action taken during the subcommittee meetings. The Senate Ways and Means Committee and Senate Committee of the Whole on Senate Sub. for HB 2365 concurred with the Governor's recommendation with no adjustments.

Conference Action House Sub. for SB 161 and House Sub. for SB 249

The **Conference Committee** concurred with the Governor's recommendation with the following adjustments:

1. Delete \$843,355, including \$315,210 from the State General Fund, to eliminate the remaining three quarters of Death and Disability payments for FY 2017. (House Sub. for SB 161)
2. Add language requiring the Director of the Budget to calculate State General Fund allotments for any state university as a uniform percentage from the total of all operating budget accounts of the State General Fund and special revenue funds of each state educational institution for FY 2017. (House Sub. for SB 249)
