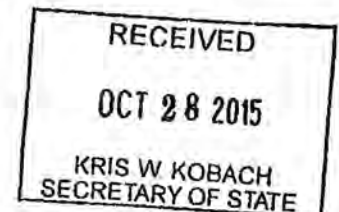
**NOTICE OF PUBLIC HEARING ON
ADMINISTRATIVE REGULATION**

A public hearing will be conducted at 9:00 a.m., on the 22nd day of January, 2016, at the Landon State Office Building, 5th Floor, 900 SW Jackson, Room 509, Topeka, Kansas, to consider the proposed adoption of K.A.R. 71-6-5 by the Kansas Dental Board.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed adoption of K.A.R. 71-6-5. All parties may submit written comments prior to the hearing to the Executive Director of the Kansas Dental Board, Lane Hemsley, Lane.Hemsley@dental.ks.gov or Landon State Office Building, 900 SW Jackson, Room 455-S, Topeka, Kansas 66612. All interested parties will be given a reasonable opportunity to present their views orally on the regulations during the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the regulation and economic impact statement in an accessible format. Requests for accommodation to participate in the hearing should be made at least five working days in advance of the hearing by contacting Lane Hemsley at (785) 296-4690 or Lane.Hemsley@dental.ks.gov. The north entrance to the Landon State Office Building is accessible. Handicapped parking is located at the north end of the Landon State Office Building, across the street from the north entrance to the building, and on Ninth Street, just around the corner from the north entrance to the building.

K.A.R. 71-6-5 is an amended regulation. The following is a summary of the amended regulation.



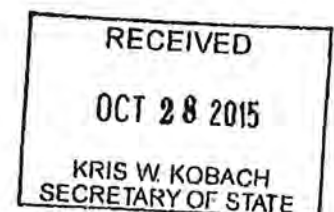

K.A.R. 71-6-5. Duty to notify board. Each supervising dentist who allows a nonlicensed person to coronal scale teeth after the effective date of this regulation shall (a) verify the nonlicensed person has proof of completing the training to coronal scale teeth required by K.S.A. 65-1423(a)(8)(E), and amendments thereto; and (b) report to the board the name and practice location of the nonlicensed person within 30 days of the effective date of this regulation or within 30 days of the nonlicensed person's first performing the coronal scaling of teeth under the supervision of the dentist, whichever is later.

The Board does not anticipate any economic impact to the Kansas Dental Board. The Board does not anticipate a financial impact on other governmental agencies, licensees and registrants, or private businesses or individuals.

71-6-5. Duty to notify board. ~~Each nonlicensed person who has received a certificate from an educational entity demonstrating successful completion of an approved course of instruction pursuant to K.S.A. 65-1423(a)(8)(E), and amendments thereto, shall meet the following requirements:~~

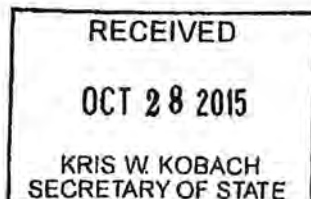
~~(a) Within 30 days of obtaining the certificate, provide a copy of the certificate to the board;~~

~~(b) notify the board, within 30 days of employment or change in employment, of the names and business addresses of all dentists who are employing or supervising the nonlicensed person; and~~

~~(c) within 30 days of any change in the identity or business location of any dentist employing the nonlicensed person, inform the board of the change. Each supervising dentist who allows a nonlicensed person to coronal scale teeth after the effective date of this regulation shall meet the following requirements:~~

~~(a) Verify that the nonlicensed person has proof of completing the training to coronal scale teeth required by K.S.A. 65-1423 (a)(8)(E), and amendments thereto; and~~

~~(b) report to the board the name and practice location of the nonlicensed person within 30 days of the effective date of this regulation or within 30 days of the nonlicensed person's first performing the coronal scaling of teeth under the supervision of the dentist, whichever is later. ECONOMIC IMPACT STATEMENT

K.A.R. 71-6-5

I. Summary of Proposed Regulations, Including its Purpose.

K.A.R. 71-6-5 establishes that each supervising dentist who allows a nonlicensed person to coronal scale teeth after the effective date of this regulation shall (a) verify the nonlicensed person has proof of completing the training to coronal scale teeth required by K.S.A. 65-1423(a)(8)(E), and amendments thereto; and (b) report to the board the name and practice location of the nonlicensed person within 30 days of the effective date of this regulation or within 30 days of the nonlicensed person's first performing the coronal scaling of teeth under the supervision of the dentist, whichever is later.

II. Reason or reasons the Proposed Regulations Are Required, Including Whether or Not the Regulations Are Mandated By Federal Law.

The regulations are being amended to assist in insuring that only properly trained nonlicensed persons engage in the coronal scaling of teeth and to allow the Dental Board to know the practice locations of nonlicensed persons engaging in the coronal scaling of teeth.

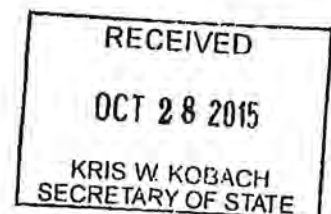
III. Anticipated Economic Impact upon the Kansas Dental Board.

There is no economic impact on the Kansas Dental Board, its licensees, or registrants other than a potential minor cost to dentists of notifying the Board as require by the regulation.

IV. Anticipated Financial Impact Upon Other Governmental Agencies and Upon Private Business or Individual.

The Kansas Dental Board does not anticipate economic impact on other governmental agencies or on private businesses or individuals.

V. Less Costly or Intrusive Methods That Were Considered.
