Notice of Hearing on Proposed Administrative Regulations

The Kansas Department of Health and Environment (KDHE), Division of Public Health, Bureau of Family Health, will conduct a public hearing at 9:00 a.m. Wednesday, October 24, 2018, in the Azure Conference Room, fourth floor, Curtis State Office Building, 1000 SW Jackson, Topeka, Kansas, to consider the adoption of proposed amended maternal and child health regulation K.A.R. 28-4-503.

A summary of the proposed amended regulation and estimated economic impact follows: Summary of Regulation:

K.A.R. 28-4-503. Timing of specimen collections. This amended regulation aligns the Kansas Newborn Screening Program with national standards for newborn screening timeliness and provides the earlier specimen collection timeframe during which a newborn screening specimen must be collected. Amendments specify the required specimen collection for an infant requiring a blood transfusion, for infants who require transfer to another institution, and for infants born outside of an institution.

Economic Impact:

Cost to the agency: There is no added cost to the agency associated with the amendments to this regulation that only change the required timeframe for specimen collection.

Cost to institutions: There is no added cost to institutions or others collecting specimens in the timeframe required by the amendments to this regulation.

Costs to other governmental agencies or units: The amendments to this regulation will not result in added costs to other government agencies.

KRIS W. KOBACH SECRETARY OF STATE 28-4-503. Timing of specimen collections. (a) The initial specimen from each infant born in an institution shall be obtained as follows:

(1) (A) Before discharge but no later than at 72 When the infant is at least 24 hours of age but less than 48 hours of age; or

(B) if the infant is discharged from the institution of birth before 24 hours of age, before the infant is discharged;

(2) before any transfer of the infant is transferred from the institution of birth to another institution; and

(3) before the infant receives any blood transfusion.

(b) The initial specimen from each infant born outside of an institution shall be obtained as follows:

(1) No later than at 72 When the infant is at least 24 hours of age but less than 48 hours of age; and

(2) before the infant receives any blood transfusion.

(c) A repeat specimen shall be obtained from each infant born in an institution or outside of an institution under any of the following conditions:

(1) The specimen is unsatisfactory as specified in K.A.R. 28-4-505.

(2) Follow-up recommendations have been issued by the department.

(3) The infant is less than 24 hours old when the initial specimen is taken. (Authorized by K.S.A. 65-101 and K.S.A. 2009 2017 Supp. 65-180; implementing K.S.A. 2009 2017 Supp. 65-180 and K.S.A. 65-181; effective, T-87-48, Dec. 19, 1986; effective May 1, 1987; amended

I. Brief description of the proposed rule(s) and regulation(s).

K.A.R. 28-4-503. Timing of Specimen Collections. This amended regulation specifies the following: 1) the revised timeframe that a newborn screening specimen is required to be collected; 2) the required collection for a well-baby, a baby born requiring a blood transfusion, and babies born who require transfer to another hospital or birthing facility; and 3) the circumstances that would require a repeat specimen collection.

II. Statement by the agency if the rule(s) and regulation(s) is mandated by the federal government and a statement if approach chosen to address the policy issue is different from that utilized by agencies of contiguous states or the federal government. (If the approach is different, then include a statement of why the Kansas rule and regulation proposed is different)

This regulation is <u>not</u> mandated by the federal government. However, this regulation as amended will align Kansas with a national recommendation by the Department of Health and Human Services for timeliness of newborn screening specimens. All four of the contiguous states have policies in place recommending collection between 24-48 hours after birth. Kansas currently recommends collection between 24-72 hours after birth.

A. The extent to which the rule(s) and regulation(s) will enhance or restrict business activities and growth;

The proposed amended regulation will neither enhance nor restrict business activities and growth.

The proposed amended regulation will have no implementation and compliance costs for businesses, sectors, public utility ratepayers, individuals and local governments or for the state economy as a whole. For hospitals and birthing facilities collecting the specimens, the proposed regulation only changes the required timeframe of collection and adds no additional costs. Costs will be absorbed within existing resources.

C. Businesses that would be directly affected by the proposed rule and regulation;

There is no additional costs to the hospitals and birthing facilities collecting the specimens in the changed timeframe required by the amended regulation. Costs will be absorbed within existing resources because hospitals and birthing facilities currently collect infant specimens.

D. Benefits of the proposed rule(s) and regulation(s) compared to the costs;

There are no additional costs. Costs of the proposed amended regulation will be absorbed within existing resources because hospitals and birthing facilities currently collect infant specimens. The proposed regulation only changes the timeframe of collection. The benefits of increasing timely and effective screenings based on earlier specimen collection will allow the KDHE Newborn Screening Program to respond more rapidly to abnormal screenings. This rapid response may have a direct correlation in the reduction of unnecessary medical costs and may result in saving babies' lives.

E. Measures taken by the agency to minimize the cost and impact of the proposed rule(s) and regulation(s) on business and economic development within the State of Kansas, local government, and individuals;

No measures were taken as there is no additional cost or impact on business or economic development within the state or on local governments and individuals associated with the amendments to this regulation that change the required timeframe of collecting infant specimens.
