NOTICE OF PUBLIC HEARING ON PROPOSED PERMANENT REGULATIONS
For
UTILIZATION OF THE FIFTH EDITION OF THE DIAGNOSTIC AND STATISTICAL MANUAL OF MENTAL DISORDERS FOR USE BY PROFESSIONAL COUNSELORS, MARRIAGE AND FAMILY THERAPISTS, ADDICTION COUNSELORS, PSYCHOLOGISTS, SOCIAL WORKERS, AND MASTERS LEVEL PSYCHOLOGISTS

The Behavioral Sciences Regulatory Board will conduct a public hearing from 9:00 – 10:00 A.M. on Wednesday, February 13, 2019 in the board conference room at 700 SW Harrison St. Ste-420, Topeka, Kansas to consider adopting permanent rules and regulations for utilization of the fifth edition of the diagnostic and statistical manual of mental disorders for use by professional counselors, marriage and family therapists, addiction counselors, psychologists, social workers, and masters level psychologists.

This 60-day notice of the public hearing constitutes a public comment period for purposes of receiving written public comments on the proposed regulations. All interested parties may submit written comments prior to the hearing to Max L. Foster, Jr., Executive Director, Behavioral Sciences Regulatory Board, 700 SW Harrison St. Ste-420, Topeka, KS 66603-3929. E-mail comments may be directed to max.foster@ks.gov. All interested parties will be given a reasonable opportunity to present their views orally at the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statement in an accessible format. 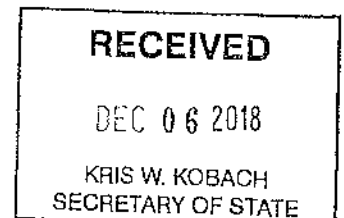

The purpose of these regulations is to change the referral source for use in the diagnosis and treatment of mental disorders used by professionals licensed by this agency. Currently the regulations require the use of the "diagnostic and statistical manual of mental disorders" fourth edition. This regulation change requires the use of the "diagnostic and statistical manual of mental disorders" fifth edition.

Statement by the agency if the rule(s) and regulation(s) is mandated by the federal government and a statement if approach chosen to address the policy issue is different from that utilized by agencies of contiguous states or the federal government. These regulation changes are not mandated by the federal government.

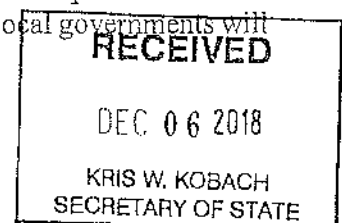
Business activities and growth will not be negatively impacted upon the adoption of these regulations. Any Behavioral Sciences Regulatory Board (BSRB) licensee is required to use the "diagnostic and statistical manual of mental disorders" as a referral source in their practice. This regulation change mandates the use of the most current edition of this manual.

B. The economic effect, including a detailed quantification of implementation and compliance costs, on the specific businesses, sectors, public utility ratepayers, individuals, and local governments that would be affected by the proposed rule and regulation and on the state economy as a whole;

Upon implementation of these regulations the economic impact of compliance costs to specific businesses, sectors, public utility ratepayers, individuals and local governments will be zero.

C. Businesses that would be directly affected by the proposed rule and regulation;

Current BSRB licensees - who also are business owners - would be required to use the most current edition of the "diagnostic and statistical manual of mental disorders" DSM as a reference. This happens to be the fifth edition.

D. Benefits of the proposed rule(s) and regulation(s) compared to the costs;

Utilizing the most current edition of the "diagnostic and statistical manual of mental disorders" will assure effective public protection for anyone who utilizes the services of the professionals licensed by the BSRB.

E. Measures taken by the agency to minimize the cost and impact of the proposed rule(s) and regulation(s) on business and economic development within the State of Kansas, local government, and individuals;

Requiring the use of the most current edition of this reference manual does not constitute a burden on the economic development within the state of Kansas. As previously indicated, the use of this manual has previously been mandated by current regulations. This regulation change only mandates the use of the most current version of the manual.

F. An estimate, expressed as a total dollar figure, of the total annual implementation and compliance costs that are reasonably expected to be incurred by or passed along to business, local governments, or members of the public.

\$150,000. As previously mentioned, BSRB statutes and regulations require the use of the current edition of this reference manual. Since the publishers of this manual have updated the current version, users of this document will need to utilize the updated version of the DSM. A new copy of this document is available for a cost of \$12 to \$30. It is estimated that 11,000 current BSRB licensees are affected by this regulation change. In many offices, it is not unusual for multiple licensees to work for a single employer. Therefore, it is very possible that one copy of the manual could be shared by more than one staff member. In addition, it is possible for a licensee to access the DSM "on-line" -- and this would not require purchase of the document. Based upon this fact, because of this change in the regulations, BSRB estimated that 5,000 copies of this manual will be ordered. This equates to a maximum fiscal impact of \$150,000. **NOTE:** This is a one-time cost. The previous version of this document was used for more than 10 years prior to updating to the current version of the document.

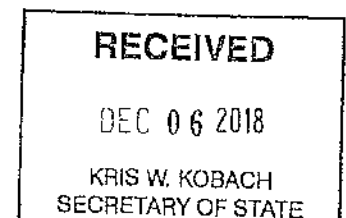
