The Behavioral Sciences Regulatory Board will conduct a public hearing from 10:00 – 11:00 A.M. on Wednesday, February 13, 2019 in the board conference room at 700 SW Harrison St. Ste-420, Topeka, Kansas to consider adopting permanent rules and regulations for licensing fees for professional counselors, marriage and family therapists, addiction counselors, psychologists, social workers, and masters level psychologists.

This 60-day notice of the public hearing constitutes a public comment period for purposes of receiving written public comments on the proposed regulations. All interested parties may submit written comments prior to the hearing to Max L. Foster, Jr., Executive Director, Behavioral Sciences Regulatory Board, 700 SW Harrison St. Ste-420, Topeka, KS 66603-3929. E-mail comments may be directed to [max.foster@ks.gov](mailto:max.foster@ks.gov). All interested parties will be given a reasonable opportunity to present their views orally at the hearing. In order to give all parties an opportunity to present their views, it may be necessary to request each participant to limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the proposed regulations and economic impact statement in an accessible format. The purpose of these regulations is to lower various licensing fees charged by this agency.

**II. Statement by the agency if the rule(s) and regulation(s) is mandated by the federal government and a statement if approach chosen to address the policy issue is different from that utilized by agencies of contiguous states or the federal government. These regulation changes are not mandated by the federal government.

**III. Agency analysis specifically addressing following:**

**A. The extent to which the rule(s) and regulation(s) will enhance or restrict business activities and growth;**

Business activities and growth will not be negatively impacted upon the adoption of these regulations. Any Behavioral Sciences Regulatory Board (BSRB) licensee that is a business owner will experience a reduction in operational expenses because of their license fee being lowered.

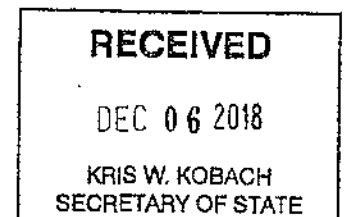
