

State of Kansas Board of Pharmacy Notice of Hearing on Proposed Administrative Regulations

A public hearing will be conducted on Tuesday, May 7, 2019 at 9:00 a.m. at the Kansas State Board of Pharmacy at 800 SW Jackson, Suite 1414, Topeka, Kansas to review and consider the adoption of proposed amended regulations of the Kansas State Board of Pharmacy.

This 60-day notice of the public hearing shall constitute a public comment period for the purpose of receiving written public comments on the proposed regulations. All interested parties may submit written comments prior to the public hearing to Alexandra Blasi, Executive Secretary, 800 S.W. Jackson, Suite 1414, Topeka, Kansas 66612-1244 or by e-mail to pharmacy@ks.gov. All interested parties will be given a reasonable opportunity to present their views orally regarding the adoption of the proposed regulations during the public hearing. In order to provide all parties an opportunity to present their views, it may be necessary to request that each participant limit any oral presentation to five minutes.

Any individual with a disability may request accommodation in order to participate in the public hearing and may request the regulations and economic impact statements in an accessible format. Requests for accommodation to participate in the public hearing should be made at least 10 business days in advance of the hearing by contacting Alexandra Blasi, Executive Secretary, 800 S.W. K.A.R. 68-11-1 and 68-11-2 are being amended to increase application and renewal fees for pharmacists, pharmacies, and other facilities registered by the Board. In response to legislative requests in 2014 related to excess Board fee funds, the Board lowered fees by 20% for all application and renewal license types. In addition, the legislature swept \$800,000 from the Board fee fund to the state general fund after fees were lowered in 2014, depleting the fee fund balance even more. These increases are within existing statutory caps, allow fees to remain competitive with other state boards of pharmacy, and are necessary to maintain a positive fee fund balance in FY 2020 and beyond. Based on the increases, which range from 25-46% for most licensure categories, the Board anticipates generating \$342,630 of additional revenue per year. - 68-11-1. Fees for examination and licensure as a pharmacist. The following fees shall be paid to the board by each applicant for examination and licensure as a pharmacist:
- (a) Each applicant for examination shall pay a fee of \$40.00 \$100.00 to the Kansas board of pharmacy.
- (b) Each applicant for reciprocal licensure shall pay a fee of \$64.00 \$125.00 to the Kansas board of pharmacy.
- (c) An additional fee of \$250.00 to evaluate the education and training shall be paid by each applicant for reciprocal licensure or examination who graduated from a school or college of pharmacy or department of a university not approved by the board.
 - (d) Each licensed pharmacist shall pay a renewal fee of \$120.00 \$150.00.
- (e) The penalty fee for a late renewal of a pharmacist license shall be \$160.00 \$200.00.

- I. Brief description of the proposed rule(s) and regulation(s).
 - K.A.R. 68-11-1 and 68-11-2 are being amended to increase application and renewal fees for pharmacists, pharmacies, and other facilities registered by the Board.
- II. Statement by the agency if the rule(s) and regulation(s) is mandated by the federal government and a statement if approach chosen to address the policy issue is different from that utilized by agencies of contiguous states or the federal government. The content of this regulation is not mandated by the federal government. Fees are consistent with other states.

- III. Agency analysis specifically addressing following:
 - A. The extent to which the rule(s) and regulation(s) will enhance or restrict business activities and growth;

In response to legislative requests in 2014 related to excess Board fee funds, the Board lowered fees by 20% for all application and renewal license types. Proposed increases will financially impact new applicants and current licensees but should not be deterrents to engaging in the practice of pharmacy in Kansas.

B. The economic effect, including a detailed quantification of implementation and compliance costs, on the specific businesses, sectors, public utility ratepayers, individuals, and local governments that would be affected by the proposed rule and regulation and on the state economy as a whole;

See attached comparative chart for an individual licensee impact as well as the total fiscal impact. The Board anticipates generating \$342,630 of additional revenue per year.

Resident and non-resident facilities registered by the Board including pharmacies, manufacturers, wholesale distributors, non-prescription drug distributors, institutional drug rooms, sample distributors, durable medical equipment providers, third-party logistics providers, outsourcing facilities, and repackagers.

The Board lowered fees for four years and maintained a steady fee fund balance until additional contributions were required for the K-TRACS program. In addition, the legislature swept \$800,000 from the Board fee fund to the state general fund after fees were lowered in 2014, depleting the fee fund balance even more. These increases are within existing statutory caps, allow fees to remain competitive with other state boards of pharmacy, and are necessary to maintain a positive fee fund balance in FY 2020 and beyond.

E. Measures taken by the agency to minimize the cost and impact of the proposed rule(s) and regulation(s) on business and economic development within the State of Kansas, local government, and individuals;

The Board intentionally omitted a fee increase for pharmacy technicians, pharmacy students, and retail dealers, which are some of the lower earners and provide necessary services.

H. Describe how the agency consulted and solicited information from businesses, associations, local governments, state agencies, or institutions and members of the public that may be affected by the proposed rule(s) and regulation(s).

Over the past three years, the agency has repeatedly notified pharmacy associations and other stakeholder groups of the dwindling fee fund balance and the inevitable fee increases. While no feedback has been provided at the times of such notifications, the Board has not recently consulted with such organizations. Licensees have expressed concern regarding Board fee funds (licensee dollars) being used for the K-TRACS program and have recommended that state general funding be appropriated for that program.
