Subject: Authority for Proposed Rules and Regulations for January 10, 2020, Meeting

Office of Attorney General: K.A.R. 16-19-1 through 16-19-3

Authorized by K.S.A. 75-771

- (a) The attorney general shall appoint a Kansas victim information and notification everyday (VINE) coordinator, and within the limits of appropriations available therefor, such additional staff as necessary to support the coordinator.
- (b) The Kansas VINE coordinator shall work with interested parties, including, but not limited to, the sheriffs throughout the state, to oversee the implementation and operation of the VINE system throughout the state.
- (c) The attorney general may appoint an advisory board to make recommendations for the implementation and operation of the VINE program. Such advisory committee, if appointed, may consist of up to five members appointed by the attorney general. One member shall be a victim advocate and one shall be a representative of the Kansas sheriffs' association. Except as provided in K.S.A. 75-3212, and amendments thereto, no member of any such advisory committee shall receive any compensation, subsistence, mileage or other allowance for serving on an advisory board appointed pursuant to this section.
- (d) The attorney general shall **promulgate rules and regulations** necessary to carry out the provisions of this section.

The secretary shall administer the provisions of this act and shall be responsible for administration and management of the fund. The secretary is hereby authorized to:

- (a) Enter into binding commitments for the provision of loans in accordance with the provisions of this act;
- (b) review applications of municipalities for loans and select the projects for which loans will be made available;
- (c) provide the governor and the legislature with an annual report prepared in accordance with K.S.A. 65-163k and with copies of the audit required under K.S.A. 65-163e; and
- (d) **adopt rules and regulations** necessary for effectuation of the provisions of this act.

Department of Health and Environment: K.A.R. 28-24-1 through 28-24-14

- (a) As used in this section, "sanitation standards" means standards for personal and environmental sanitation and for the prevention of infectious and contagious diseases.
- (b) The secretary of health and environment shall **adopt rules and regulations** establishing sanitation standards for professions, shops, salons, facilities, clinics, schools and colleges regulated by the state board of barber examiners or the state board of cosmetology.
