**Re:** Report of the November 15, 2021, Meeting of the Joint Committee on Administrative Rules and Regulations

With this report, the Joint Committee on Administrative Rules and Regulations (Committee) provides its comments on rules and regulations reviewed at its meeting of November 15, 2021. Agencies are asked to respond to each comment or request for information; responses are compiled and maintained by staff of the Kansas Legislative Research Department.

### All Agencies

The Committee encourages all agencies to reduce the numbers of rules and regulations, such as by not replacing outdated rules and regulations that are being revoked.

#### Department of Agriculture, Division of Water Resources

New Article 19, Local Enhanced Management Areas: KAR 5-19-1, definitions; 5-19-2, LEMA plans; KAR 5-19-3, public hearings; KAR 5-19-4, due consideration for past voluntary water conservation; KAR 5-19-5, review and modification of a designated LEMA.

The Committee commends the work of the local enhanced management areas.

#### Kansas Department of Health and Environment

KAR 28-1-40, definitions; KAR 28-1-41, contact tracers; KAR 28-1-42, contact data; communication with contacts; KAR 28-1-43, surrender or destruction of contact data; KAR 28-1-44, sunset provision.

The Committee requests information on the costs to the State for contact tracing, including, but not limited to, costs for software, hardware, databases, training, hiring, and salaries, and the funding used to cover those costs. The Committee also requests information concerning which counties in the state issue written quarantine orders.

## **State Board of Technical Professions**

KAR 66-7-1, applications.
