STATE GENERAL FUND (SGF) RECEIPTS

July through December, FY 2024

Total receipts through December FY 2024 were \$48.0 million, or 1.0 percent, **below** the estimate. The component of SGF receipts from taxes only was **\$50.7 million**, or 1.1 percent, **below** the estimate. (This is the second monthly report based on the revised estimate for FY 2024 made by the Consensus Revenue Estimating Group on November 9, 2023.)

There were two tax sources above the estimate by more than \$1.0 million and five tax sources below the estimate by more than \$1.0 million. Those **tax sources** are bolded in the attached table.

Individual income tax receipts were **above** the estimate by **\$6.4 million**, or 0.3 percent. Withholding taxes continues to reflect strong growth over the prior year.

Corporation income tax receipts are **below** the estimate by **\$28.9 million**, or 4.2 percent. While corporation income tax collections are below the estimate, this may be attributable to the timing of receipts as certain payments are made at the end of the month and may not be receipted by the State until January. Information in the January SGF Receipts memo will provide additional insight into the state of this tax source.

Sales and use taxes combined were below the estimate by \$19.8 million, or 1.1 percent. Retail sales tax receipts were below the estimate by \$23.9 million, or 1.7 percent; compensating use tax receipts were above year-to-date expectations by \$4.1 million, or 1.0 percent. The consensus revenue estimating group will continue to analyze receipts in this tax source for possible changes in the April estimates.

Insurance premiums tax receipts were **below** the estimate by **\$2.7 million**, or 3.8 percent. This shortfall reflects unanticipated refunds that were required based on amended tax filings.

Non-tax receipts are \$2.7 million above the estimate. Interest earnings were below the estimate by \$1.5 million. Agency earnings and miscellaneous revenues exceeded the estimate by \$4.9 million.

It is important to remember that a comparison of just two months may not be a reliable basis upon which to identify a trend for the balance of the fiscal year. Receipts in upcoming months, primarily next month, will likely be more meaningful in identifying any developing trends regarding how major tax sources are faring relative to the revised estimate done in November.

There has not been a Certificate of Indebtedness issued for FY 2024.
