LAWS EFFECTIVE JULY 1, 2019

A total of 68 bills became law during the 2019 Session. Of those bills, 54 have provisions that became effective on July 1, 2019 (generally referred to as "publication in the statute book"). A summary of those bills is reported below by topic and subject. Comments are included for bills that may have multiple effective dates.
