## **LAWS EFFECTIVE JULY 1, 2023**

A total of 98 bills became law during the 2023 Session. Of those bills, 77 have provisions that become effective on July 1, 2023 (generally referred to as "publication in the statute book"). A summary of those bills is reported below by topic and subject. Comments are included for bills that have multiple effective dates, or as additional information is warranted.
