A public hearing will be conducted at 10:00 A.M Wednesday, April 19, 2017 in Room 1051 of the Landon State Office Building , 900 SW Jackson, Topeka, to consider the adoption of proposed change in one existing regulation relating to payment of fees. It is proposed that the fee for verification of licensure be increased.

All interested parties may submit written comments prior to the hearing to the Executive Administrator of the Kansas State Board of Nursing, Room 1051 Landon State Office Building, 900 S.W. Jackson, Topeka, Ks. 66612. All interested parties will be given a reasonable opportunity to present their views, orally or in writing, concerning the adoption of the proposed regulation during the hearing. Phone comments will be taken by calling 1-877-278-8686 (access code 615670) at 1:00 P.M. the day of the hearing. In order to give all persons the opportunity to present their views, it may be necessary to request each participant to limit any oral presentations to five minutes. 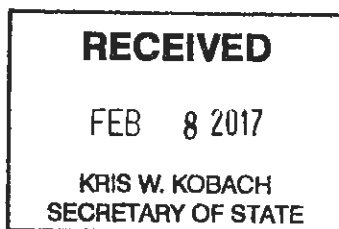

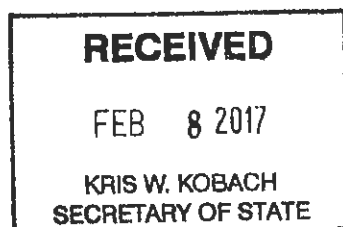
