Re: Report of the July 18, 2022, Meeting of the Joint Committee on Administrative Rules

and Regulations

With this report, the Joint Committee on Administrative Rules and Regulations (Committee) provides its comments on rules and regulations reviewed at its meeting of July 18, 2022. Agencies are asked to respond to each comment or request for information; responses are compiled and maintained by staff of the Kansas Legislative Research Department.

# **Department of Agriculture**

Grain warehouse: KAR 4-25-1a, definitions; KAR 4-25-2, record retention; KAR 4-25-4, revoked (was storage space, exception); KAR 4-25-5, storage liability reports; KAR 4-25-7, public warehouse receipts; form; KAR 4-25-8, scale tickets; inbound form; KAR 4-25-9, scale tickets; outbound form; KAR 4-25-10, grain bank grain; KAR 4-25-11, revoked (was allowance to licensed warehouses for the purpose of handling and storage of dry edible beans); KAR 4-25-15, revoked (was definition of 12-month period); KAR 4-25-16, fees and charges; KAR 4-25-19, licensed storage, conditional storage, and emergency storage; KAR 4-25-20, undermeasurements and overmeasurements of stored grain; KAR 4-25-21, unpaid grain contracts; KAR 4-25-22, safety of facilities; KAR 4-25-23, disciplinary actions.

The Committee requests information on the demographic information collected on infants with notifiable conditions, specifically whether information on the race of the infant is collected.

The Committee requests information on the roles played by nonprofit organizations in the development of these rules and regulations and in the Kansas Birth Defects Surveillance Reporting Manual to be adopted by reference in KAR 28-4-521.

#### **Board of Nursing**
