Notice of Hearing on Proposed Administrative Regulations

A public hearing will be conducted by the Department of Revenue on Wednesday, November 8, 2023, at 9:00 a.m., in the Secretary's Conference Room on the fourth floor of the Mills Building, 109 SW 9th St., Topeka, KS 66612, regarding the proposed revocation of K.A.R. 92-19-200, 92-19-201, 92-19-202, and 92-19-203.

K.A.R. 92-19-200 through 92-19-203 supported a Kansas food sales tax refund program that has been repealed.

The Department of Revenue does not anticipate any significant economic or environmental impact on governmental agencies or units or the general public because of the changes to these regulations. The last time an individual could claim a food sales tax refund was for tax year 2012. 2013 HB 2059 replaced the refund program with a nonrefundable income tax credit for certain individuals who purchase food in Kansas.
