## October 28, 2022

The organization and duration of legislative sessions in Kansas is defined by Article 2, Section 8 of the *Kansas Constitution*. Sessions are to begin on the second Monday in January. Even-numbered years are limited to 90 calendar days, though this limitation can be overridden by a two-thirds majority vote of both chambers. There is no constitutional limitation during odd-numbered years. The dates and duration of each session during this time period are listed in the table below.<sup>1</sup>

- 1 The data presented excludes Special Sessions held in 1987, 1989, 2005, 2013, 2016, 2020, and 2021.
- The 2018 Legislature held *Sine Die* on the same day as its Wrap-up Session adjournment day pursuant to SCR 1615.
- The Senate, pursuant to HCR 5014 (which permitted the Senate President to call a session for consideration of an appointment to the Court of Appeals), met on May 14. (The House was in session for 78 days.)
- The 2020 Legislature adjourned earlier than the prescribed deadline for first adjournment due to the COVID-19 pandemic. Prior to adjournment on March 19, the Legislature passed SCR 1615, which extended deadlines for second house consideration and prescribed the date for return (April 27) and also allowed the Legislative Coordinating Council to extend that return, given health and safety concerns, to May 21, 2020. May 21 was designated as *Sine Die* in this resolution. (The Legislature did not return on April 27; select legislative committees were permitted to meet on May 12.)
- The 2022 Legislature, pursuant to HCR 5037, adjourned *Sine Die*, during which its action was prescribed to "conduct legislative matters and to review and respond to any final decision or order issued by the Kansas Supreme Court in the case of *Rivera v. Schwab* regarding the constitutionality of the reapportioned United States Congressional districts enacted in 2022 Sub. for SB 355."
