FY 2022 MILITARY AND EXPEDITED OCCUPATIONAL LICENSURE REPORT

[KSA 48-3406](#) requires the Kansas Legislative Research Department (KLRD) to annually collect licensure information regarding expedited military and non-military licensure law provided for by 2021 HB 2066 and report such information to the Office of the Governor; House Committee on Commerce, Labor and Economic Development; Senate Committee on Commerce; House Committee on Appropriations; and Senate Committee on Ways and Means. Data collection began in FY 2022, with the first report to the Legislature to occur during the 2023 Session.

The FY 2022 report follows.

Analysis

In FY 2022, state agencies issued 28,567 licenses under the expedited licensing provisions established in 2021 HB 2066.

License applications eligible for expedited licensing procedures totaled 29,800 with 95.9 percent of the licenses approved and issued. The table below provides the breakdown of license applications and approval percentage by category.

Due to the Kansas State Board of Cosmetology transitioning their database software during the reporting period, the agency was unable to provide a breakdown of license applications by category type, which is why the percent of licenses issued for military spouses exceeds 100.0 percent.

* Professional Licenses are issued by the Kansas State Department of Education and include the Professional School Leadership License, Professional School Specialist License, and Professional Teaching License.

When an agency receives an application, the applicant typically needs to provide additional information or credentials to complete the application.

The average time between agency receipt and applicant completion for all license applications was 21.2 days, with the longest average period being for non-military members seeking a veterinary license at 143.0 days and the shortest average period being for licenses for all category types from the Kansas State Department of Education at 0.1 days.

The average time between agency receipt of a completed application and issuance of the license for all licenses was 3.7 days, with the longest average period being 87 days for a military member seeking an optometrist license and the shortest average period being 0.1 days for licenses for all category types from the Kansas State Department of Education.

During FY 2022, state agencies denied a total of 55 license applications in total. Common reasons for denial include the following justifications:

- Criminal history;
- Failure of applicant to respond;
- Failure to meet requirements;
- Legal actions; and
- Past disciplinary action.

State agencies also revoked a total of 26 licenses with common reasons for revocation being criminal history, failure to maintain licensing requirements, and voluntary forfeiture.
